These Terms and Conditions set out your rights and responsibilities when you join and invest through (and our rights and responsibilities when we supply you with) the Heritage SIPP. **Alltrust Services Limited** (company number **05365396**) is authorised and regulated by the Financial Conduct Authority ("the FCA") (firm reference number 461966) and **Alltrust SIPP Limited** (company number 05398985) acts as the Asset Trustee for the SIPP appointed by **Alltrust Services Limited**. Both companies' registered offices are at: Warner House, 123 Castle Street, Salisbury, England, SP1 3TB.

#### 1.0 THE AGREEMENT

1.1 These Terms and Conditions ("Terms and Conditions") constitute the entire agreement ("the Agreement") between you and us ("the Parties").

## 2.0 APPLICATION AND ADMISSION TO THE SIPP AS A MEMBER

- The SIPP is a Self-Invested 2.1 Personal Pension product governed by its Trust Deed and Rules, which is an HM Revenue and Customs (HMRC) registered pension scheme under pension scheme tax reference 00704690RB, and to provide the detailed under the services Agreement. You accept that admission to membership of the SIPP is at our absolute discretion and that these Terms and Conditions apply from the date of your Application;
- 2.2 You have been admitted on the basis of the information you disclose, the options you select and the declarations you make in your Application and we will create one or more arrangements in the SIPP for you in which will reside your benefits. Your benefits will be comprised of such cash and other investment assets that

- shall exist in such combination and of such value from time to time as derived from such pension contributions made to the SIPP by you or on your behalf, such non-tax relieved top up payments you may pay into the SIPP with our prior approval, and from such pensions transferred to the SIPP from your other registered pension schemes;
- 2.3 the Heritage SIPP Kev Features sets out and provides of the details pension transfers, pension contributions, investment assets and pension benefits permitted by us, and other information on how the SIPP operates and the Features must be read in conjunction with the making of an application to join the SIPP;
- 2.4 you will provide us with proof of identity and proof of address in accordance with the exact requirements detailed in our Application to join the Heritage SIPP. We use an Anti-Money Laundering & Compliance platform to confirm your identity and address, the identity and address of anyone else providing or receiving monies on your behalf and,

where required, the identity and address of other connected parties. As part of these checks, the Anti-Money Laundering & Compliance platform uses credit reference agencies to verify identity and address details. By entering into the Agreement you confirm that you consent to the above;

- 2.5 you agree that where we suspect fraud, we may share information about you with a fraud prevention agency. Where information in your application is incomplete or incorrect we may adjust your application to make it valid, but we are not bound to do so. We will only make changes using details you have previously given to us in writing;
- may refuse vour instructions at our absolute discretion and we may not provide you with a reason for doing so. We may refuse your application for, but not limited the following reasons: provision of incomplete or untruthful information by you, your failure to observe these and Conditions, a Terms disagreement or dispute with us, as a result of regulatory or legal requirements, or another commercial reason;
- 2.7 we will treat you as a 'Retail Client', which means you benefit from the highest level of regulatory consumer protection under the FCA rules. If you are resident outside the UK and are deemed an 'Overseas Client', we will provide the same high level of service to you but you must seek your own independent financial advice on the extent of any protection you may enjoy

under the FCA rules and the legal or taxation implications of being an Overseas Client who is a member of the SIPP. We are unable to give you such advice and will not take responsibility for assisting you in complying with any legal and taxation matters that effect you, including the completion of any paperwork about your SIPP or its investments;

2.8 to continue as a member of the SIPP, you must have a suitably qualified regulated financial adviser (adviser) unless we agree otherwise.

#### **3.0 TERM**

3.1 This Agreement is valid until termination in accordance with Clause 39.

#### 4.0 SERVICES

- 4.1 We are authorised regulated by the FCA as an operator of personal pensions and the SIPP is a regulated retail investment product. We also provide administration services in our capacity as Scheme Administrator for the SIPP. The Asset Trustee shall hold your SIPP investments. The services provided to you by us are specified in our SIPP Services and Fees. Fees will be charged for the provision of these services in accordance with Clause 7 of these Terms and Conditions;
- 4.2 we will provide to you only the Services or such other services that are agreed in writing between us and we will charge the current fees for those services as set out in our Services and Fees. You may request from us a quotation of

- fees for other services that we may be able to provide at our discretion;
- 4.3 the services described in Clause 4.1 and Clause 4.2 shall collectively be known as ("the Services").

#### 5.0 ADVICE

- 5.1 we will not provide you with any form of financial advice, legal advice, taxation advice, pension advice (including general or specialist pension transfer) or any other kind of specialist advice. You are responsible for obtaining and funding such advice, unless it is a bona fide cost of the SIPP, and the advice you receive is the sole responsibility of the party advising you. We will not have sight of, review, comment or opine on any advice you are provided with under circumstance, whether follow the advice or not, as we are not authorised or qualified to provide advice and this is not a service that we provide or a service contained within the Services under these Terms and Conditions;
- 5.2 without prejudice to clause 2.8, if you are not UK resident, we recommend that you seek regulated independent financial advice from a suitably qualified authorised adviser in respect of all aspects of the SIPP, including but not limited to the decision to select and to apply to join the SIPP, pension contributions, transfers, SIPP Investments, the drawing of pension benefits, taxation matters, and the effects of all SIPP charges on your SIPP, including investment

- charges levied on your SIPP by investment managers, advisers or investment providers or those deducted or otherwise met from the SIPP investments themselves, including checking the level of those charges is not excessive, that investment contractual terms appropriate and are not likely to impact on your needs an requirements and that you consider the existence of any investment penalties or other withdrawal fees, especially in relation to contractual terms and, where applicable, that the level of any commissions paid to your adviser or a third party are not excessive so that you understand the impact of all charges and commissions on the investment performance of your SIPP investments;
- 5.3 you are responsible for ensuring that the investment strategy assumed as part of any pension transfer advice provided to you by your adviser is implemented in full on receipt of the transfer by us into your SIPP, and that the investment strategy does not deviate from the advice you received have and vou acknowledge that to do so may fundamentally undermine the premise on which the original advice was given to you, notwithstanding the fact that investment decisions may need to be modified in circumstances such as but not limited to, market investment and volatility, regulatory change, the instability of the proposed investment provider, intervention by any applicable regulatory body that might effect the investment decision,

the investment itself, the investment provider, or the status of the adviser providing the advice or a decision by us to withdraw an investment option for one of the above reasons;

- 5.4 You and your adviser are responsible for managing your investments and, the liquidity needs of the SIPP, whether to fund fees or benefits, and your own income needs;
- 5.5 where you choose not to take regulated independent financial advice, the decisions that you make in respect of any transaction relating to the SIPP, including, but not limited, to those transactions summarised in Clause 5.2 of these Terms and Conditions, will be at your own risk. All such transactions will automatically be deemed by us to be carried out on a direct execution only and non-advised basis;
- 5.6 if you are an Overseas Client, any UK tax returns or, international tax matters or your returns, are responsibility. Without prejudice to clause 2.8, we recommend that you seek independent regulated financial advice from suitably qualified FCA authorised adviser and that you take suitable legal and tax advice in the UK or the relevant jurisdiction territory of your residence.

### 6.0 CHANGES TO THESE TERMS AND CONDITIONS

6.1 We may change these Terms, and Conditions including the Services and our fees, from time to time in whole or in part, by

giving you reasonable notice of the change. We will notify you of changes to the Terms and Conditions by sending you the amended Terms and Conditions by post or by email. We will also make the amended Terms and Conditions available on our website.

We will only change these Terms and Conditions for the following reasons:

- to reflect changes in the costs and charges that we incur or expect to incur in providing the Services to you, and/or to take into account changes in the rates of inflation, taxes or interest;
- b) to reflect current or future changes in law, HMRC practise rules or regulations, or decisions of the Pensions Ombudsman Service or the Financial Ombudsman Service;
- c) to meet changes in FCA rules or regulatory requirements or industry guidance or best practice;
- to make these Terms and Conditions easier to understand or fairer, or to correct mistakes;
- e) to expand on or to clarify our own internal polices;
- to reflect changes in market practice or conditions;
- g) to reflect the way that our services are used and ensure that the costs of the Services are allocated fairly among our clients; or
- h) to provide for the introduction of new systems or services and changes in technology or products.

- 6.2 we will give you at least 30 days' notice of any change to these Terms and Conditions that may be detrimental to you, unless we are required to make the change sooner (for example for regulatory reasons). If we make a change for a reason not set out above which is detrimental to you, you will be entitled to end your contract with us without paying the fees to wind up the SIPP and transfer out to pension another registered scheme and any applicable fees for the transfer of your investment assets in specie, for a period of 90 days from the date of such change becoming effective.
  - You will be responsible for third party fees incurred in transferring the SIPP and investment assets to another pension scheme;
- 6.3 incidental changes (such as clarity, drafting and typographical amendments) are made immediately and will be available on the Alltrust website or in printed form upon request.

## 7.0 FEES, STANDARD FEE INCREASES AND CAPITAL ADEQUACY

- 7.1 Your SIPP establishment and first year's administration fee is due immediately on your admission to the SIPP for our provision to you of the Services and will be settled from the SIPP. The contractual payment date will be the earlier of:
- 7.1.1 the date on which sufficient pension contributions or sufficient pension transfers have been received into the

- SIPP to meet the total cost of the fees; or
- 7.1.2 90 days from the date of our invoice;
- 7.2 we will settle your annual fee from the SIPP on the anniversary of your admission to the SIPP in advance and thereafter in each subsequent year, for the Services to be provided;
- 7.3 we reserve the right to increase our fees in line with annual movement in Average Weekly Earnings or such other index as is issued by the Office for National Statistics from time to time and as published one month before we review all fees;
- 7.4 we are required to sufficient capital to meet the regulatory rules set by the FCA to operate the SIPP. This capital adequacy requirement designed to protect our clients if we, as an operator, fail or if we choose to withdraw from the SIPP market, to cover the cost of the transition of your SIPP to a replacement operator. FCA rules now directly link this capital requirement to the value of the SIPP and the type of Investment assets and the liquidity of those assets held in it. The SIPP only accepts liquid investment assets which are assets that are capable of being accurately, independently and fairly valued at any one time and that are readily realisable within 30 days, whenever "Standard required, called Assets" by the FCA. The SIPP does not accept "Non-Standard Assets" which are illiquid assets, except our absolute at discretion. Part of the fee we

charge covers the cost of the impact your SIPP has on our capital requirement. We may specific capital charge а requirement related fee at the point at which you join the SIPP, respect of pension pension contributions and transfers received at any time, on the growth of the SIPP fund value if the SIPP has increased in fund value, or at the point at which an investment is made, or because there has been a change in the FCA rules that determine the levels regulatory capital we required to hold. We may charge a capital requirement related fee without reference to you SIPP investment а becomes suspended or is made otherwise illiquid and ceases to be a standard asset to meet our changing capital requirement and such charges may have substantial cost implications and we may charge a fee to cover the time cost of any additional work we are required to do or we may insist that the investment is sold and sell the investment without reference to you to ensure compliance, in which case we will charge you the applicable administration for dealing with fees investment disposal. We will not be held responsible or liable where such action results in an investment loss. It is your and your adviser's responsibility to ensure your SIPP investments remain Standard Assets at all times:

7.5 without prejudice to clause 7.4, if your SIPP contains nil valued assets because the investment is impaired or suspended and

- the investment returns to value, this will increase the overall value of our Assets Under Administration which will in turn increase our capital requirement. Should such an event occur, we will charge a fee as a contribution to cover the automatic increase in our capital requirement;
- 7.6 we may choose not to increase our fees for the Services in a particular year;
- 7.7 fees for additional services shall be charged in advance by us on receipt of instructions received from you or your appointed adviser to commence work on a particular transaction and fees will be settled from the SIPP automatically when we commence the work;
- 7.8 where we receive instructions to carry out any work that gives rise to an additional annual fee, we will charge the first annual fee in respect of this work at the point at which you instruct us to provide the additional service and then in each subsequent year at SIPP anniversary. Such fees shall be charged in full and shall not be charged on a pro rata basis;
- 7.9 fees for additional services will be charged in full for aborted transactions and we reserve the right to vary the charge to a proportion of the full fee for any work undertaken on an aborted or pending transaction, or agree additional fees with you for complex transactions;
- 7.10 additional services with fees charged on

- a time cost basis will be calculated as follows:
- a) work undertaken by our administration staff is charged at £250 per hour;
- work undertaken by a Director is charged at an increased rate of £350 per hour;
- 7.11 we will charge Value Added Tax in addition to our fees at the current UK prevailing rate for clients who are resident in the UK. We will not charge Value Added Tax in respect of our fees charged to clients who are not resident in the UK;
- 7.12 you agree to remunerate us for the Services undertaken by us either automatically under these Terms and Conditions or at your request and receipt of application forms or written or verbal instructions by us from you or your adviser constitutes a request for our services. You hereby authorise us to settle such fees from the SIPP in accordance with these Terms and Conditions and at our absolute discretion;
- 7.13 except in so far as we are not permitted to do so by law, we reserve the right to exercise a lien over all documents, funds and records in our possession in relation to the SIPP until all outstanding fees and disbursements are paid in full.

### 8.0 PAYMENT TERMS AND UNPAID DEBTS

8.1 All fees that we charge for the Services are due for payment immediately from the SIPP on the due date and fees and all other charges due to third parties applicable to the SIPP and any other costs incurred

- because of your investments will be deducted from the cash in the SIPP, or, where applicable, from the investments themselves by the investment provider and it is your responsibility to understand the fees that are levied by third parties and how they are calculated and how and from where they are settled;
- 8.2 Our fees will be settled annually from the SIPP or at the point at which fees are due additional services accordance with these Terms and Conditions. We will set aside sufficient funds for next year's anticipated fees when you set up your SIPP, when we settle your annual fee in subsequent years and when fees for additional services are settled from the account. We require you to maintain cash in SIPP bank account equivalent to 3 years annual administration fees. If the drops below balance amount, we will disinvest sufficient funds from the SIPP investments in accordance with these Terms and Conditions to maintain the minimum cash balance. The investment provider may require you to countersign any disinvestment instruction. You must not allow the SIPP to become overdrawn. If the outstanding charges due exceed the cash available in the SIPP to pay us we may sell investment assets in the SIPP the cover outstanding amounts, in accordance with these Terms and Conditions;
- 8.3 if you owe us money which we cannot collect from the SIPP we

have the absolute right of sale of investment assets in the SIPP (including those held in joint names) without recourse to you or your adviser to meet amounts you owe to us. If there is insufficient cash in the SIPP to meet any fees arising in the first three months following your admission to the SIPP, we will not sell investment assets in the SIPP to pay these fees until the first three months following your admission to the SIPP have elapsed;

- 8.4 if we must sell any of your investment assets to meet your obligations, we will charge the appropriate transaction fee or a fee based on time spent at the rate set out in the Services and Fees;
- 8.5 we will review the SIPP for outstanding fees on a regular monthly basis. When selling investment assets to cover fees we will normally:
- a) sell investment assets from the largest available holding by value without notice, sufficient to cover the outstanding fees at our sole discretion. You should contact us if selling your largest holding may present a problem. If there are restrictions on selling the largest holding, we may sell an alternative holding at our discretion;
- b) where the sale of an investment asset would result in greater than 90.9% of the value of that holding being sold, we will sell the entire holding. This calculation shall be based on the most recent valuation available at the point of creating the sale instruction;

- 8.6 we do not accept any liability if this sale is made at a disadvantageous time or if you incur any other liability in relation to the sale e.g. penalties;
- 8.7 you will continue to be personally responsible to us for any outstanding balance due after investment assets have been sold or in the event investment assets cannot be sold and the difference in value will be immediately payable to us by you personally if a shortfall remains;
- 8.8 we may charge you interest on money you owe to us at 5% above the Bank of England Base Rate for all fees that remain outstanding for more than 14 days. We may also make credit reference agencies aware of your payment record. This may affect your financial standing in the future. We may also immediately cancel, terminate and/or suspend any contract with you without having any resulting liability to you. If we need to take legal action against you for recovery of a debt then you will be liable for all expenses incurred by us;
- 8.9 where we sell an investment asset in the SIPP, that sale may result in a gain or loss for you. We are not responsible for any losses you incur or for any tax consequences or associated costs or other liabilities which arise because of any sale;
- 8.10 if there are insufficient investment assets in the SIPP to meet the outstanding amounts we may enforce

payment from your own personal funds and lapse the SIPP with no value.

### 9.0 THIRD PARTIES FEES AND DISBURSEMENTS

- 9.1 Professional fees and disbursements for services charged by third parties such as but not limited to: solicitors, financial advisers, investment advisers, tax advisers, accountants, banks, actuaries, value added tax experts and stockbrokers are responsibility and are, to the extent that they are incurred in respect of the SIPP, a cost of the SIPP, and will be met out of SIPP funds at our absolute discretion; SIPP funds at our absolute discretion;
- 9.2 in addition to where we sell the SIPP's investment assets to cover fees under Clause 8, we may need to raise funds for other reasons, for example to send tax relief back to HMRC or to pay third party fees or charges. In these circumstances, we will act in accordance with Clause above but will only sell holdings to the degree required to meet the outstanding amounts.

#### 10.0 INVESTMENT DECISIONS, INSTRUCTIONS, ADVICE FEES AND INVESTMENT COSTS

10.1 The SIPP provides access to standard assets only. A list of the types of investments that we permit is contained in the Key Features. We also publish a list of Investment Providers that can be accessed by the SIPP. The SIPP is a Self-Invested Personal Pension and therefore the investment transactions you

- or your adviser instruct us to undertake with or without regulated advice are selfdirected by you and we will not take part in any of your decisions, investment related or otherwise;
- 10.2 we will carry out due diligence in respect of all Investment Providers and investment proposals to:
- a) take reasonable steps to determine the validity of the investment's legal structure;
- b) determine the appropriateness of holding the investment in the SIPP, strictly and only in terms of its compatibility with pension tax law and HMRC practice;
- take reasonable steps to verify that the investment is a bona fide investment being run and managed by a competent firm or competent individuals;
- d) determine whether the investment permitted to be made by ordinary retail clients or if it is an investment the marketing of which is restricted only to retail clients who are either high net worth investors, sophisticated investors or another restricted or controlled category of investor; and
- take reasonable steps to determine if the investment will not on the face of it result in unauthorised payments;
- 10.3 our agreement to make an investment does not constitute a recommendation to you or endorsement by us of the investment or constitute participation by us in the investment decision itself or the provision of any kind of advice,

- which we are not authorised to provide you with;
- 10.4 we will not permit anv investments into the SIPP that our investment due diligence process and we will permit or refuse an investment at our absolute discretion. Our due diligence process is not a substitute for your own need to take professional advice or for you or your adviser to carry out own comprehensive your investment due diligence to satisfy yourself as to the validity, risks and suitability of the investment before you make an investment decision as to whether to invest or not;
- 10.5 the presence of an investment provider and their investment on our panel of approved SIPP investment providers from time to time or a decision by us to permit an investment in the SIPP is not a recommendation or endorsement by us of the investment provider investment and we will never earn commissions or have any other financially incentivised relationship with any investment provider at any time. Our panel of investment providers or permitted investments are the providers simply investments we are prepared to accept and deal with in respect of the SIPP, is subject to change and we may withdraw access to investment an provider at any time and at our absolute discretion without reference to you;
- 10.6 should you self-certify as either a high net worth investor or a sophisticated investor or elect to be treated as a professional

- investor in order to make an investment restricted to those categories of investor which preclude investment by an ordinary retail client, you will be responsible for the validity of making such a declaration, certification or election and we shall bear no responsibility for the implications of you doing so, any false certification or for the investment you make as a consequence and any breach of law if you are not permitted by law to make such a declaration, certification or election. We may, although we shall not be bound to do so, request evidence from you to support the validity of your declaration, certification or election, prior to making any restricted investment;
- 10.7 we will accept no liability for the failure of investments selfdirected by you or your advisers or for investment losses due to poor performance or otherwise. We will take reasonable steps to carry out due diligence in a timely fashion but this will be dependent on the cooperation of you, your adviser and the investment provider and we may agree a fee with you for investment complex diligence as undertaking investment due diligence does not form part of the Services. We will not accept responsibility for delays caused by any party during our due diligence process or the investment process itself and we will not accept liability financial losses any whatsoever or howsoever including incurred, if exercise our absolute discretion to reject an investment you or your adviser has proposed;

- 10.8 you authorise us to act from time to time on instructions given in any manner (including but not limited to verbal, written and electronic instructions) in circumstances where we reasonably believe those instructions to have emanated from you or any person, adviser or firm you have authorised to act on your behalf;
- 10.9 if you do not provide us with investment instructions then pension contributions, transfer payments from registered pension schemes, investment sale proceeds or investment return in the form of cash and other cash deposits will remain in the SIPP trustee bank account and may not achieve a very good rate of interest or any investment return at all. It is your responsibility to identify and monitor cash deposits that have not been invested and we not accept responsibility or liability for losses or lack of or poor investment return if you do not invest this cash;
- 10.10 you may instruct us from time to time and provide us with a written mandate in a form prescribed by us, instructing us to pay adviser remuneration to your appointed adviser in accordance with our Adviser Remuneration Policy Adviser Terms of Business. Such instructions will remain in until we receive alternative instructions from you or until we suspend in accordance with the terms of our Adviser Terms of Business;

- 10.11 By instructing us to make an investment vou agree investment charges being deducted from your investments an investment provider under the terms of the investment application. You must ensure the terms of an investment, its charges and any remuneration agreements between the investment provider and your adviser are with your consistent expectations before instructing us to make any investment on your behalf;
- 10.12 Where you are selling investments in a currency other than GBP, you must consider the exchange rate implications of doing so as the proceeds will be remitted to the SIPP bank account in GBP and we are under no obligation to remind you of this and we will not accept liability for currency conversion transactions that you deem to be unfavourable.

### 11.0 SERVICE STANDARDS

- 11.1 We will provide you with administration services in accordance with the standards as detailed in our SIPP Services Standards. We reserve the right to vary Service Standard times in the event of a change in governing legislation or internal procedure and any such variation will be confirmed in advance and in writing;
- 11.2 where we are asked by you to perform a number of services simultaneously, it is your responsibility to take into account and factor into your requirements the length of time we allocate to a particular service under our Service

Standards and to note that the performance of some services are contingent on the completion of other services first and in such cases, our Service Standard turnaround times will stack, example: set up of a new SIPP and a pension transfer to your new SIPP.

## 12.0 APPLICABILITY OF THE SIPP TRUST DEED AND RULES

- 12.1 You acknowledge that the SIPP is governed by the Trust Deed and Rules in respect of the Heritage SIPP to which you have applied to become a member ("the Rules") as amended by subsequent deeds. The Rules set out how the SIPP operates and our powers and the powers of the Asset Trustee;
- 12.2 if there are any conflicts between these Terms and Conditions and the Rules, the Rules will prevail. If there is any conflict between the Terms and Conditions, the Rules, or any of documents other our concerning the SIPP, and the Finance Act 2004 amended), then the Finance Act 2004 (as amended) will prevail. All payments or transfers to or from the SIPP and the operation of the SIPP in general will be subject to the legislation in force at the time;
- 12.3 we act as the SIPP Scheme Administrator and will administer the SIPP in accordance with the Rules. By applying for membership of the SIPP you agree to be bound by the Rules, which are available from us on written request.

### 13.0 BANK ACCOUNT AND CURRENCY CONVERSION

- 13.1 We will direct the Asset Trustee to open a trustee bank account or accounts with our banking partner for the SIPP to which the Asset Trustee will be sole signatory and the Asset Trustee will operate account(s) under our direction. We will never accept any inducements from a bank as to our choice of banking partner and we will never deduct for our benefit any sum from the interest your bank deposit earns;
- 13.2 We may make changes to the SIPP's banking arrangements at our absolute discretion, including a change to our choice of banking partner and we will notify you in advance of the change, we will update you as appropriate during any migration process and we will confirm to you when the process is complete;
- 13.3 we will endeavour to provide you with view only online access to the bank account, to assist you in monitoring the account;

- 21.3 cash in the SIPP will be held in the trustee bank account opened for the SIPP. Interest may be earned on the cash balances held in the SIPP bank accounts. The applicable interest rate on cash balances from time to time is available from us upon request. The interest received will be credited directly to the SIPP bank account by the bank. We do not retain any portion of the bank interest the SIPP bank account earns, all of it is credited to the SIPP;

21.4 under no circumstances will we hold client

If we are not provided with sufficient information to identify transfer payment or to allocate it to the SIPP immediately on receipt, advance investment instructions will only be placed on receipt of the required information from transferring provider;

- 33.4 in accordance with Clause 5, you and your adviser are responsible for ensuring that the investment strategy assumed as part of any transfer pension advice provided to you by your adviser or any qualified third party adviser is implemented in full on receipt of the transfer by us into your SIPP, and that the investment strategy does not deviate from the advice you have received, except where it is appropriate to do so, for example, where there has been market movement or a genuine reason to change the strategy because it is prudent to make such a change, and where any change is made it is your responsibility to consider the impact this will have on outcomes for you, taking into account the pension transfer advice you received on the basis of the original investment assumptions;
- 33.5 you are responsible ensuring that a pension transfer to your SIPP will not prejudice your position leaving you worse off and for taking and heeding appropriate advice before instructing the transfer, including carefully considering the potential consequences, should decide to act contrary to the advice you have received.

### 34.0 TAKING BENEFITS AND INCOME DRAWDOWN

34.1 An application to take benefits may be made by you by contacting us for the relevant form, but we will not provide you with any sort of advice as we are not authorised to provide you with advice.

Before requesting a lump sum or income withdrawal from the SIPP, you must ensure there is sufficient cash in the SIPP to cover the payment due. We may permit benefit payments in specie by transfer of an investment asset provided sufficient cash is available to pay the income tax if applicable;

- 34.2 cash payments will be issued by electronic bank transfer and we will aim to make payment within ten working days of the receipt of a fully completed benefit request form, and of sufficient un-invested cash becoming available;
- 34.3 if at any time you take a from payment uncrystallised portion of the SIPP which means that less than £1,000 will remain in the SIPP, we will close the SIPP Account and pay out the full amount as taxable income, less any applicable closure fee. When determining whether your remaining balance will be less than £1,000 we will not take account of the cash and/ or investment assets in any other SIPP you have;
- 34.4 if you elect for Income Drawdown, additional Terms and Conditions apply and you should read these before applying. Lump Sums will usually be paid by next day Faster Payment or, if requested or if a requirement due to payment value, by CHAPS and the SIPP will pay any applicable bank fees.

### 35.0 INSUFFICIENT FUNDS FOR BENEFITS AND INCOME DRAWDOWN

35.1 You are responsible for ensuring that sufficient cash is available to cover any taxfree cash due, your gross income payments and all Where there fees. insufficient cash for us to meet a requested income payment in full, a reduced payment of the available will be made, save that we will not make any payment if the amount of the reduced payment would be less than £50.

### 36.0 TIMING OF CHANGES TO INCOME DRAWDOWN

36.1 All requests to change any aspect of Income Drawdown must be submitted in writing, and will be effective at the next payment date that occurs at least ten working days after receipt of your request.

### 37.0 CANCELLATION OF INCOME DRAWDOWN

37.1 You have the right to cancel setting Income up Drawdown for the first time. Please refer to the Key Features for details. If you decide to cancel we will deduct fees and charges for any services that we have provided during cancellation period and you must return any lump sums and/or income payments already received.

### 38.0 STOPPING INCOME DRAWDOWN

38.1 You may choose to stop Income Drawdown and instead use the funds to purchase an annuity or transfer to another

registered pension scheme.

### 39.0 TERMINATION AND NOTICE

- 39.1 These Terms and Conditions apply until your membership of the SIPP ceases or the SIPP lapses with no value and if the SIPP continues after your death the Terms and Conditions will apply to your nominated beneficiaries and any successors. If no monies are received within six months of you opening a SIPP, we may close the SIPP and these Terms and Conditions will cease to apply:
- 39.2 these Terms and Conditions may be terminated by you, with immediate effect, at any time, by giving written notice to us of your intention to transfer the SIPP to another registered pension scheme or purchase an annuity in accordance with the Trust Deed and Rules and making a request in writing;
- 39.3 without affecting any other right or remedy available to us, these Terms and Conditions may be terminated by us with immediate effect, at any time, by giving written notice to you, if:
  - a) you fail to pay any amount due under the Agreement on the due date for payment and remain in default not less than 14 days after being notified in writing to make such payment;
  - b) you commit a material breach of any of these Terms and Conditions which is irremediable or (if such

- breach is remediable) you fail to remedy that breach within a period of 7 days after being notified in writing to do so;
- you are liquidated or dissolved or declared bankrupt or otherwise unable to pay your debts as they fall due;
- d) we have reasonable grounds for believing you have committed or are about to commit a crime in connection with your use of the SIPP; or
- e) we are required to terminate these Terms and Conditions by any competent regulatory authority or as a matter of law.
  - In these circumstances, we will provide you with advance written notice where it is reasonably practicable to do so;
- 39.4 in addition to the right to terminate set out above, we may also terminate these Terms and Conditions for any other reason, by giving you at least 30 days' written notice;
- 39.5 termination of these Terms and
  - Conditions shall be without prejudice to the completion of transactions already initiated under these Terms and Conditions. Such transactions will completed by us as soon as practicable, if there are sufficient funds in the SIPP to all outstanding US amounts owing to us under these Terms and Conditions;
- 39.6 on termination of these Terms and Conditions you will pay us all outstanding costs, fees,

charges or expenses relating SIPP the and transactions already initiated prior to termination or in respect of fees owed for aborted transactions if we are unable to settle them direct from the SIPP. You will also pay any expenses necessarily incurred by us in terminating these Terms and Conditions and in concluding outstanding obligations and you will bear any losses necessarily realised in concluding any outstanding obligations;

- 39.7 cheques or payment orders that remain un-cashed and residual account balances may not attract further interest;
- 39.8 fees will apply to the termination and closure of the SIPP in accordance with our published Services and Fees;
- 39.9 in the event of the termination of the Agreement all fees then due to us shall be payable and fees paid shall be refundable and there will be no pro rata basis applied for calculating annual or other fees owed to us. We will deal with endeavour to matters promptly and to fully with all cooperate relevant parties. We will charge a transfer out fee for any pension transfers to an alternative registered pension scheme and any fees applicable in respect of any other transactions we may undertake as part of the Services while dealing with termination. Fees will continue to be due and payable until termination is complete and the Services have ceased;

- 39.10 on death, representatives should send us either the original or a certified copy of your Death Certificate, and we will continue to rely on these Terms and Conditions until the SIPP is closed and they will continue in force if the SIPP remains open for the benefit of your nominated beneficiaries and successors;
- 39.11 if you apply to transfer the SIPP, either to purchase an annuity or to transfer to another registered pension we will not scheme, transfer the SIPP until we received have outstanding tax relief due to you, unless you provide specific instructions to the contrary. Pension transfers and annuity purchases will only be permitted on receipt of the relevant form which you can obtain from us and upon the completion by us of full due diligence on the receiving registered pension scheme in order to satisfy ourselves that the transfer is a permitted, authorised and bona fide pension transfer and that the receiving scheme is a bona fide scheme capable of accepting the pension transfer. We will not be responsible for any delays dealing with third parties, including HMRC while satisfying ourselves that the pension transfer is a permitted transfer or while giving effect to the transfer of investment assets out of the legal

ownership of the Asset Trustee to a new trustee or any financial losses due to delays. Pension such transfers of crystallised funds will only be permitted as full transfers and partial transfers of crystallised funds will not be permitted. transfers of In specie assets will be made first and cash transfers will be paid last, once all in specie transfers are complete. We will exercise our absolute discretion as to the timing order in which transfers of investment assets and cash are made but this will not affect your statutory rights to a pension transfer;

39.12 we will not provide you with any sort of advice on the purchase of an annuity or on transfers to another registered pension provider as we are not authorised to provide you with advice.

### 40.0 EVENTS OUTSIDE OUR CONTROL

40.1 An "Event Outside Our Control" means any act or event beyond our reasonable control, including without limitation; strikes, lock-outs or other industrial action by parties, commotion, riot, invasion, terrorist attack or threat of terrorist attack, war (whether declared or not) or threat or preparation for war, fire, explosion, storm, flood, earthquake, subsidence, epidemic or other natural disaster, or failure of public or private

telecommunications networks;

40.2 we will not be liable or responsible for any failure to perform, or delay in performance of, any of our obligations under these Terms and Conditions that is caused by an Event Outside Our Control. If an Event Outside Our Control takes affects the place that performance of our obligations under these Terms and Conditions we will notify you reasonably soon as practicable and our obligations these Terms Conditions will be suspended and the time for performance of our obligations will be extended for the duration of the Event Outside Our Control.

#### **41.0 THIRD PARTY RIGHTS**

41.1 A person, other than one of our group companies, who is not a party to this Agreement shall have no right under the Contracts (Rights of Third Parties) Act 1999 to enforce any of its terms.

#### **42.0 SEVERABILITY**

42.1 If any part of the Agreement is held to be invalid or unenforceable, the remainder will continue in full force and effect.

#### **43.0 UNAUTHORISED PAYMENTS**

43.1 We may, from time to time, be charged with a scheme sanction charge by HMRC in respect of unauthorised payments made from the SIPP. A scheme sanction charge is a standalone charge to tax that becomes payable by the scheme administrator when a

scheme chargeable payment is made in accordance with the 2004 (as Act Finance amended) and whilst we will make reasonable efforts to any transaction payment which we reasonably believe will be deemed to constitute an unauthorised payment, in the event such a payment arises, the scheme charge will sanction deducted from the SIPP and we shall not be personally liable.

#### **44.0 LIMITATION OF LIABILITY**

- 44.1 It is hereby declared by the Parties that we and the Asset Trustee have no beneficial interest in the SIPP, that the Asset Trustee's interest in the SIPP is as a trustee only and that our total aggregate liability and the liability of the Asset Trustee individually or together shall be in all respects and for all purposes (including without limitation in tort (including negligence), breach of statutory duty, contract, misrepresentation, restitution otherwise howsoever arising) limited to the value of the SIPP and shall exclude (to the fullest extent permitted by law) any liability for economic losses (including loss profits, business, contracts, revenues or anticipated savings); or any loss of goodwill or reputation; or any special, indirect consequential loss or damages in any case, whether or not such losses were within the contemplation of the Parties at the date of the Agreement;
- 44.2 you agree to fully indemnify us and the Asset Trustee against

any and all financial losses or legal liability in respect of the investment assets held in the SIPP at your direction including tax charges we may incur due to unauthorised payments.

### 45.0 GOVERNING LAW AND JURISDICTION

- 45.1 The terms of the Agreement shall be governed and construed in accordance with the laws of England and Wales and the Parties agree to submit to the exclusive jurisdiction of the English Courts;
- 45.2 we will communicate with each other in English;
- 45.3 these Terms and Conditions are based on our understanding of current legislation and the practices of HMRC, HM Treasury and the FCA as at the date the Terms and Conditions were written. If HMRC or HM Treasury change or clarify legislation or FCA regulations change we will not be liable for any resultant loss howsoever incurred.
