- Fees and Charges: For the first three months following this transfer, we will maintain the same
  fees and charges structure as previously applied by PSG. After this three-month period, fees
  and charges will be reviewed. Should they increase, you will be notified in advance as per the
  terms of your contract.
- 2. **Transfers Out of Your SIPP:** Any transfers out of your SIPP will be subject to the existing terms, including any applicable transfer fees. These terms are the same as your previous agreement with PSG. Please note that you may also incur the fees of a financial adviser if you or the proposed SIPP operator decide that any such transfer should only happen upon you receiving financial advice to that effect.
- 3. **Regulatory Compliance:** The FCA has been made fully aware of this transfer of the personal pension scheme business from PSG to Alltrust.
- 4. **Fair Value Assessment:** Under FCA rules, we are required to ensure that our SIPP products provide fair value and that our view on this is supported by a documented value assessment.
